Personal Property

Intake

During initial intake into the Detention Center, all personal property is inventoried, secured and maintained by Corrections Staff until release.

During Incarceration

No personal clothing will be accepted during visitation or through the mail except for court clothing. All other items may be purchased through the Commissary.

After Release

Any personal clothing remaining after release will be maintained in a secured area for up to a thirty (30) day period, it will be disposed of in accordance with Maryland Law.

Deposits in Inmate Accounts

Any money an inmate has at the time of incarceration will be deposited into an institutional account in the inmate's name for commissary purchases.

To place money into an inmate's commissary account, it can only deposited into their account via kiosks in Visitation via cash, debit card or credit card, or online at www.smartdeposit.com. No funds are accepted through the mail.

Use of the onsite Commissary Kiosks

- Cash or Credit Card only
- No bills less than \$5.00 (NO COINS)
- The address on your driver's license must match the billing address on your credit card.

Requirements for Mail

- Mail must be 10 pages or less per envelope
- Page size must be no larger than 8.5" x 11"
- Mail can include written or typed pages, photos, drawings or greeting cards. (No Polaroid photos)
- Any mail received with postage due, staff will refuse it and return it to the sender if possible
- No glitter, glue, tape, 3D elements, or electronic components (lights, music, animation)
- No items containing, depicting, or relating to sexually explicit activity, gang activity, illegal activity, violence, drug, or alcohol use, etc.
- No photos of nude or partially clothed persons
- No illegal substances or any other items considered as contraband
- No magazines, books, or packages mailed to mail processing center
- No cash, personal checks, or money orders mailed to the mail processing center
- No originals of important documents such as birth certificates, driver's licenses, social security cards, green cards, etc., as these items cannot be returned
- No original photos or other irreplaceable or valuable items.

Video visitation login is www.paytelconnect.com. These visits can occur either one time a week at the Detention Center for free or unlimited at your home or cell phone for \$0.30 a minute. Offsite video visits are unlimited. You can also send a 60 second video message to your loved one for \$0.60. All calls are subject to monitoring and recording.

Work Release

No contact visits beginning May 1, 2025. Only video visitation is allowed.

Registration will begin one half hour prior to the start of each visitation period and conclude one half hour prior to the end of each visitation period.

All visitors must have photo identification and proof of age and be properly registered prior to entry into the visiting area. Visitors under the age of eighteen (18) must be accompanied by an adult (unless the visitor is the inmate's spouse). You are allowed one (1) - thirty (30) minute visit per week. You must terminate the visit as directed by Corrections Staff. The maximum number of visitors is four (4).

Failure to follow the directions of Corrections Staff may result in the termination of your visitation privileges.

Rules for Visitors

- Visitors must have proper/current photo identification. (No Photo Identification - No Visit)
- 2. No animals are permitted on Detention Center property or left secured in vehicles. Certified service animals are allowed in the facility during visitation.
- 3. No bags are allowed in the visitation area. All bags must be secured in your vehicle or secured in a locker. Lockers are in the visitation lobby and cost \$0.25 per use.
- 4. Cell phones and cameras are not permitted in the visitation area. Anyone caught using a cell phone or taking pictures in the visitation area will have their visitation privileges suspended.
- 5. Any damage to the visitation area (i.e. lockers, phones, furniture) will result in criminal charges.
- 6. All visitors are subject to random searches of personal items and clothing.
- 7. All visitors' vehicles are subject to search.
- 8. Any visitor attempting to introduce contraband into the facility will be detained pending investigation by law enforcement officers. Subsequent arrest, criminal charges and revocation of visitation privileges will occur for this offense.
- 9. Obscene actions or gestures will result in immediate termination of the visit. You will be required to leave the visitation area immediately.
- 10. All visitors will have their photo taken prior to visiting. Refusal of this will result in loss of visitation privileges.
